Have you completed your 24 hours of classroom instruction and now need to complete your driving instruction? Have you started a course with a different provider and are unsatisfied with your driving experience? Either way, we now offer **two** packages you can choose from to transfer to SafeWay Driving to complete your drivers ed program!

1. SafeWay's BTW Only Transfer Package includes:

- For drivers who need the minimum in-car training to receive completion certificate
- 7 Drive Hours
- 7 Observation Hours
- Total Cost: \$599
- *Price may vary by location

2. SafeWay's Partial BTW Only Transfer Package includes:

- For drivers who need to complete between <u>one to six in-car lessons</u> to receive completion certificate
- Each drive includes one drive hour and one observation hour
- Cost: \$100 per Drive
- Total Cost: \$100 to \$600 (depending on how many in-car lessons needed)
